

Rhythm & Ride presale PBR World Cup 2018 Competition

Terms and conditions

- 1.** Instructions on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this competition is deemed as acceptance of these Terms and Conditions.
- 2.** Entry is open to residents of Australia aged eighteen years or over only. Employees of the Promoter and their immediate families, suppliers, associated companies and agencies are ineligible to enter. Persons under the age of 18 years are not considered adults and therefore are not able to enter. If a winner is discovered to be under 18, they will automatically be disqualified.
